MEETINGS

Our last public meeting took place on 2nd December last, when Mr. Brian Norcliffe spoke on the problems of the small garden. Mr. Norcliffe, who is himself a landscape gardener, gave a most interesting talk which was followed by many questions. About forty people attended the meeting and several have since said how much they enjoyed it.

MEMBERSHIP RENEWAL

EALING CIVIC SOCIETY

The Committee have decided to affiliate the Brentham Society to the Ealing Civic Society. The Civic Society has been prominently in the news lately due to its efforts to obtain a revision of the Ealing Town Centre Development proposals, but it is also continually concerned with maintaining environmental standards in Ealing generally and has assisted this Society on a number of occasions. Two members of our Committee, Mr. Scanlan and Mr. Hicks, are on the Executive Committee of the Civic Society.

PROPOSED DEVELOPMENT AT BRENTHAM CLUB

MEMBERSHIP RENEWAL

As reported in the local press last December, Ealing Council has rejected a third application by the Brentham Club to build an indoor bowling green adjacent to the present building, with additional car-parking facilities. The main reasons given for refusing the application were that such a development would generate a considerable amount of extra traffic through the estate and that the design and scale of the proposed building would be 'unneighbourly' to adjoining properties in Meadvale Road.

PROPERTY MAINTENANCE

One of our declared aims last year was to try and provide a cheaper means of house repair and decoration by arranging for work to be done jointly on a number of houses by the same firm; the houses would not necessarily have to be adjacent to each other. Each householder would deal directly with the firm concerned regarding their own needs, choice of colour schemes, etc. All you would have to do to benefit from the scheme is to obtain a quotation for the work through the Society. We shall then be able to give a useful service to members seeking craftsmen in these trades.

HOW TO CUT YOUR HEDGE WITHOUT REALLY TRYING

Although it may seem unseasonable to think about hedge-cutting in the middle of January, we are anxious to organise a service for those who need it before the Spring onslaught begins. As mentioned in Newsletter No. 5, a resident on the estate is willing to undertake this job on a regular basis, but before we can negotiate terms we must have some idea of the total numbers involved.
